The court may rule that the city cannot collect the fine from the defendant, or if the defendant fails to appear and pay the fine within the time specified by law, that the fine shall be and is hereby levied against him. The defendant must then either pay the fine or appeal to the court of common pleas. The decision of the court may be affirmed, set aside, or reversed on appeal. (b) A fine collected hereunder shall be paid into the general fund of the city. (c) A proceeding hereunder shall be civil in nature, and the proceedings and rules of civil procedure shall be applicable. The court shall not specify any fixed or definite term for the fine or penalty. Each fine collected shall be remitted to the clerk of the city and used by him for the city treasurer. (d) A judgment entered hereunder shall be a final judgment. The clerk shall issue execution forthwith and the defendant shall have thirty days thereafter in which to file an action to nullify or vacate the judgment. Failure to file such action within that time shall render the judgment final and binding. (e) This section may be cited as the "Fines and Forfeiture of Property Act.".
