Gov. Greg Abbott announced his bill to suspend licenses on Tuesday, in a press conference with transportation officials and city and county officials. It's aimed at solving the state's budget gap. The Texas Department of

Transportation said it would also have to pay the fine. Senate Joint Resolution 10 would require the Department of Public Safety to mail a formal notice to a driver before suspending a license. It's currently known as a "hold" on a license. Drivers can contact DPS and request a hearing to have the hold lifted, meaning they can drive. Despite finding, or more likely because of finding, work In the past, the agency typically issued the "hold" on the spot when the driver failed to pay fines and fees. The bill says a driver should receive five days of written notice before the suspension. It also requires DPS to give an in-person hearing before suspending a license. Other states already have some variation of the same, said Elva Martin, who represents Texans for Public Justice, a nonprofit that advocates for criminal justice reform.
